Jessica Cooper spent 22 years as a judge, first at the 46th District Court, followed by 14 years on the Oakland County Circuit Court. She also served six years on the Michigan Court of Appeals, before leaving the bench in 2007 to become both a commercial and labor arbitrator for the American Arbitration Association. She was also certified as a 312 Fact Finder for the Michigan Employment Relations Commission. She was elected the Oakland County Prosecutor in November 2008, and is the first female Prosecutor in Oakland County's History. The presentation will include a concentration on the topic of sexting [sex + texting/the transmission of sexual images between cell phones]. The Prosecutor is committed to assisting the youth, their parents, and the schools with addressing these problems.

Houston Fitness Consultants was founded in 1994. As active members of Oakland County and Clarkston, Dan Houston and his wife Cherie are committed in educating their community on subjects such as childhood obesity, exercise and nutrition.
